Is there a roadmap for energy storage in the Netherlands?

In the Netherlands, there has also historically not been a roadmap or detailed industrial strategy with supportive legislation, policy, taxation reliefs, or investment incentives for the energy storage market.

Is energy storage legal in the Netherlands?

Although renewable energy projects in general are possible under current legislation, the Netherlands has no specific legislation for energy storage. The legislator has drafted a bill combining and improving the current Electricity and Gas Act also known as “STROOM”.

Does Energy-Nederland need a gas storage facility?

Gas Storage Energie-Nederland emphasizes the importance of gas storage facilities for security of supply, but notes that they are not automatically filled. In 2022, interventions were necessary due to high gas prices. For Bergermeer, Energie-Nederland proposes to fill the volume with an alternative solution.

What technologies are developing in the east of the Netherlands?

Smart energy Hub: Smart decentralised energy system that produces, stores and uses sustainable energy locally.

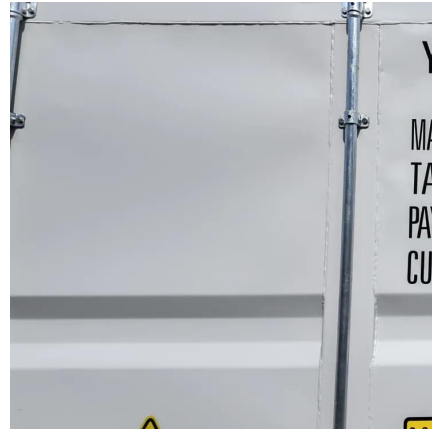

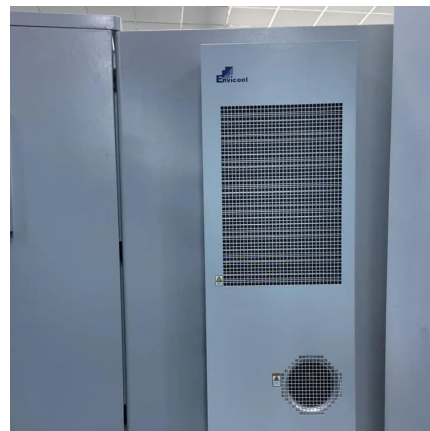

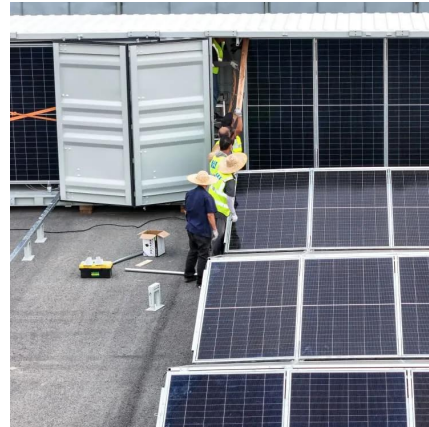
