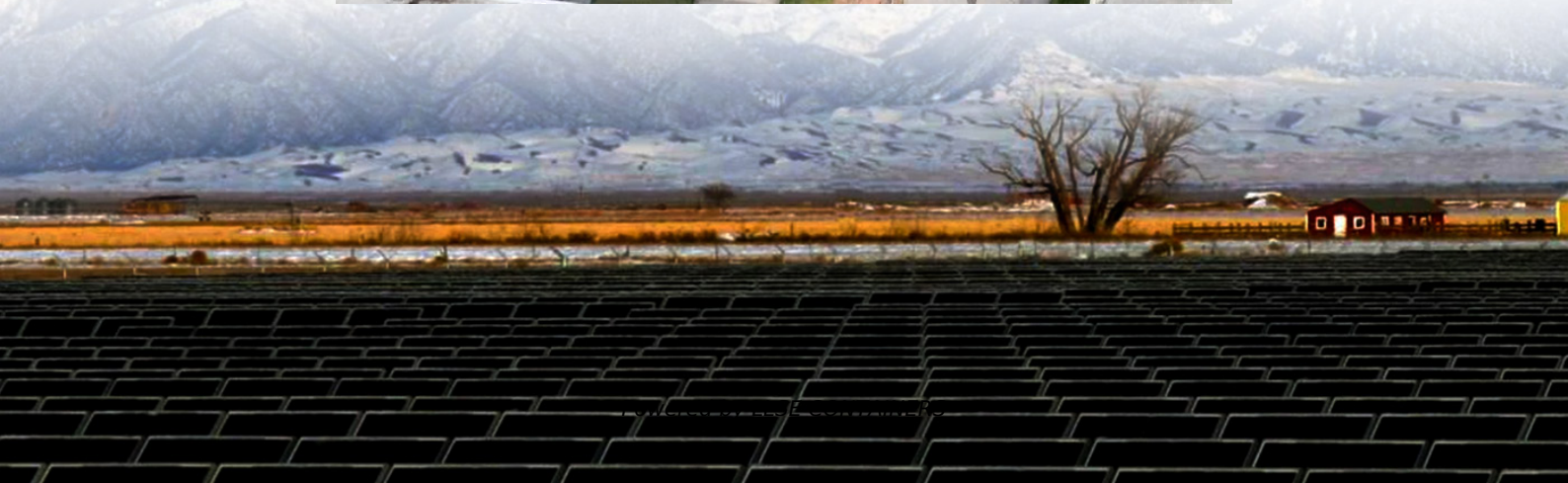

Overview

What are the shipping requirements for lithium batteries?

Some general shipping requirements to transport lithium batteries internationally include: Lithium batteries weighing over 35kg must be approved by the national authority of the shipping and destination country before shipment. Defective or damaged lithium batteries must not be transported.

How to export goods from the UAE to international markets?

Exporting goods from the UAE requires compliance with local regulations, whether via sea, air, or road. Below are the essential steps for exporting from the UAE to international markets: Sea Exports For sea exports, the exporter must book a container through a shipping agent and ensure all necessary documentation is in order: Air Exports.

Are batteries allowed in air freight?

There have been incidents of batteries causing fires within the aircraft and forcing emergency landings. Batteries are not allowed in unaccompanied luggage by air freight. If not inside a device like a smartphone, the batteries must be in a hard cased container.

Are lithium batteries shipped in a container?

There are three packaging categories for lithium batteries if they are being shipped in a container. When shipping lithium batteries, it is crucial to check the rules and regulations ahead of transportation, or work with an experience shipping partner to ensure that your cargo is shipped following best practices.

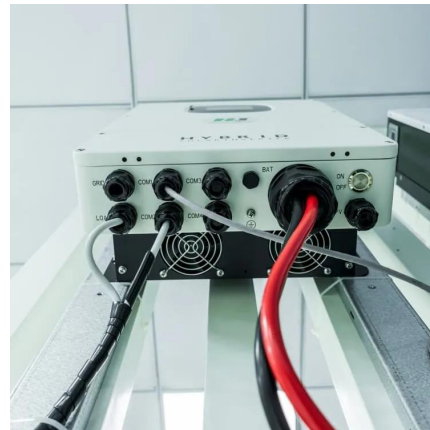

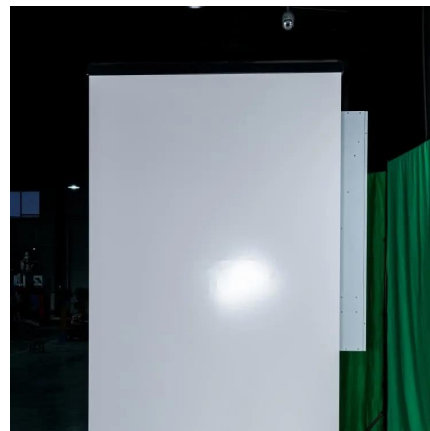

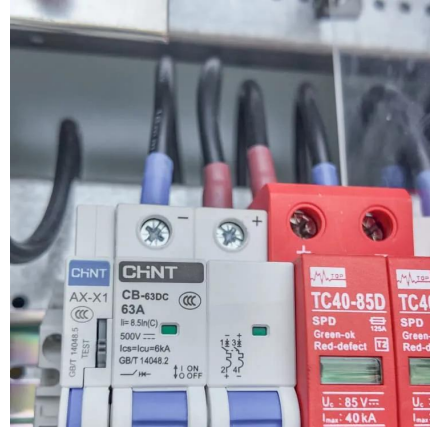
