Is EVE Energy forming a joint venture in Turkey?

Eve Energy's subsidiary, Hubei Eve Power Co Ltd, signed a memorandum of understanding with Turkey's Aksa Jeneratör Sanayi A.Ş on January 12, and the two plan to set up a joint venture in Turkey, according to a statement by the Chinese power battery maker on the Shenzhen Stock Exchange yesterday.

How much money will EVE Energy Invest in a car battery project?

On June 8, 2023, Eve Energy said its board of directors agreed that its subsidiary Eve Power Hungary Kft would invest up to RMB 9.97 billion (\$1.4 billion) in a project to build large cylindrical batteries for passenger cars in Hungary.

Will a Thai company build a battery plant in Thailand?

On July 27, the company said it signed a memorandum of understanding with a Thai company to build a joint venture in Thailand to construct a battery production site in the country with a capacity of at least 6 GWh.


